**11. Tendring District Local Plan Update:** Following on from the public consultation on the Local Plan review in March 2025 a draft spatial strategy has been published by TDC which proposes expansion of most of the district's towns and villages, including new settlements along the A120. The proposals include a new housing site for 30 dwellings on land north of Rectory Road, Wrabness. Town and parish councils are to be informally consulted on the spacial strategy and public consultation on the full Local Plan update is expected later in 2026.
